#### **CUPE 1943 AND CUPE 1909**

Introducing the new joint newsletter between CUPE 1909 – Ross Memorial Hospital and CUPE 1943 – Peterborough Regional Health Centre. We are working together to produce this newsletter at the beginning of every month so that workers at Ross Memorial and Peterborough Regional can receive up to date, authoritative and consistent information about the potential merger of the two hospitals.

We will update you on any developments in the merger process, news of upcoming events or special information sessions, and answer any questions you may have about the potential merger.

We know that there is a lot of uncertainty at this time. Sometimes this uncertainty can lead to a lot of rumors and misinformation spreading around. This newsletter aims to clear up some of that misinformation and dispel any rumours, so that we can all be on the same page with information about the merger process as it unfolds. To help us provide up to the minute information about the potential merger, CUPE 1909 and CUPE 1943 are also contributing to **www.cupehospitals.ca**. This central website has all the information you will need to understand what will happen during a merger process. Here you will be able to find the most detailed information about hospital mergers and the Public Sector Labour Relations Transition Act (PSLRTA) process. There will be full explanations about what happens to your collective agreement, seniority, job security etc. if the two hospitals merge.

All information that we hand out will be found on this easy to search website. All new information about the merger process will be posted as soon as we know about it. To the get the most up to date information or to verify something you've been hearing around the workplace, you should visit **cupehospitals.ca** first. Go to the Hospital List tab and find your workplace. If the information you are looking for isn't there, let us know and we will get it up there.

### WHAT IS PSLRTA?

The Public Sector Labour Relations Transition Act (PSLRTA) was passed in 1997 when the Ontario government began to downsize public services through mergers, amalgamations and restructurings in the municipal, school board and hospital sectors. PSLRTA establishes certain rights for workers affected by a workplace merger. It sets a framework to determine the appropriate bargaining units in an amalgamated workplace and which union should represent the workers.

In 2005 PSLRTA was expanded to apply to provincial government/LHIN-initiated health services integration and restructuring.

Any decisions about the merger process between Ross Memorial and Peterborough Regional will be based on PSLRTA. So even though we don't have a lot of detailed information at this time, we can look at PSLRTA to answer some questions that you might have.
